ReCreate Terms and Conditions of Membership

ReCreate Ireland is a registered charity operating as a social enterprise. Membership of ReCreate is open to any group or individual who adheres to ReCreate's **Terms and Conditions of Membership**.

Membership of ReCreate entitles groups and individuals to use the services provided by the charity.

- Any person or any group using these services must be a current member.
- Only the persons named on the membership form can use the centre.
- Membership is based on an annual calendar. Membership runs until the 31st of December.

VISITING RECREATE

- Upon arrival at ReCreate, members must sign in and register their visit and number of visitors.
- For Health and Safety reasons, all children must be accompanied by an adult.
- Some of our materials may be a hazard to children, and will be taken at the discretion of the member.

FAIR USAGE POLICY

- Any materials supplied by ReCreate must be used solely for the activities of the member group named on the membership. The materials must not be resold, exchanged or used for any other purpose.
- Materials must not be used for commercial or private use. Any member found selling our free materials will have their membership withdrawn.
- Art and Education Resource Store Ireland Limited trading as ReCreate, its directors, servants, agents, suppliers, members and benefactors make no warranty as to the condition of the product supplied to members as to its fitness or suitability for any purpose. All express or implied conditions as to the condition, fitness or suitability of the product are excluded.
